The effort and planning behind the TGFG Golf Tournament to raise awareness and funds is truly humbling. We are forever grateful for your contribution. Thank you for joining in on our fight to end homelessness amongst our veterans.

Because of your dedication and commitment to giving back to the community, we will be able to continue with our mission, which is “the successful transition of military veterans and their families through the provision of housing, counseling, career development and comprehensive support.” Your investment in our mission will help us maintain and grow our ability to serve and protect those who have served and protected our nation.

Over the last year, we have enrolled over 275 veterans into our program. We are proud to report that over 82% of the veterans who enter into our program maintain their sobriety during their stay here. Also, while only 43% of veterans enter with existing income, over 80% exit the program with income. These are just a few examples to show that we are making headway in reducing homelessness among veterans on Oahu in a very positive way... And we will remain vigilant in our mission until there are no veterans left to suffer the hardship of homelessness.
